Education and Academia

Alan Ross (History, 2005) Assistant Professor at the University of Vienna

After postdocs and teaching posts in the UK, Germany and France, I became Assistant Professor (Tenure Track) at the University of Vienna. My job involves research, accruing third-party funding, graduate and undergraduate teaching as well as outreach activities.

Rachel Chambers (Geography, 2005) Geography Teacher, Coast Mountain Academy

After graduating from Hertford in 2008, I spent 2 years working as a surfing and climbing instructor, which was followed by 9 months of solo travel around the world. I completed a Post Graduate Certificate of Education at Exeter University and started teaching geography in a secondary school in Cornwall. During my 4 years working in the UK I also took on additional roles of Head of Lower School and in my final year became a member of the Senior Leadership Team. In 2016 I left the UK to work a season in Whistler Canada, in 2019 I became a permanent resident of Canada and transferred my teaching qualifications across. I now work as a teacher at Coast Mountain Academy, which is an independent high school with a large emphasis on outdoor education. I still reside in Whistler and will be applying for my Canadian citizenship at the end of the year. As well as teaching I am qualified to instruct snowboarding, climbing, kayaking, surfing, mountaineering and soon to add skiing to this list.

Michelle Sahai (Biochemistry, 2007) Senior Lecturer in Biomedical Sciences at the University of Roehampton

I am a Senior Lecturer in Biomedical Sciences at the University of Roehampton, London. At Roehampton, I teach both undergraduate and graduate students and I am also research active. This post was a traditional progression from my D.Phil in Computational Biochemistry via a Postdoctoral fellowship at Weill Cornell Medical College in Manhattan, NY, USA. Prior to this I was an undergraduate student at the University of Toronto, Toronto, Canada specialising in Pharmacology and Toxicology. I also completed my Masters at the University of Toronto, in Medical Biophysics. My current research requires High Performance Computing (HPC) infrastructure to perform computational modelling and molecular dynamics (MD) simulations of membrane proteins. I am particularly interested in the interactions of small molecules with these proteins. At present I am investigating the effect of synthetic (designer) drugs on monoamine transporters.

I am responsible for analysing companies from across the world in the renewable energy space and coming up with investment ideas for the investment fund that I work on. Once I qualified, I moved to the British Virgin Islands to practice law, but in 2017 I was on the island when Hurricane Irma hit, so I came back to the UK after that. We have since won 10 awards, appeared in Vogue, Forbes, Elle and more, and are now stocked on Deliciously Ella's webshop. As Chief Scientific Officer of Hanway Associates, Henry advises UK and international clients on cannabis research, licensing, policy and business strategy, and has also helped create a number of other companies and brands.
